#### NOTE ON THE BIBLIOGRAPHY

References in the footnotes are to these sections (which are distinguished by capital letters) and within these sections each book or article has assigned to it a number which is quoted in the footnotes. In these, so as to provide a quick indication of the nature of the work referred to, the author's name and the date of publication are also included in each reference. Thus 'Finley 1979 (G 164) 100' signifies 'M. I. Finley, Ancient Sicily, revised edn London, 1979, p. 100', to be found in Section G of the bibliography as item 164.
